- 2) Captain John's Fawn Harbor and Marina will not be held liable for any damage or loss to docks, gangways, or equipment that should occur during storage, removal, or return including but not limited to adverse weather conditions or lake levels.
- 3) If storing my boat with Captain Johns I understand that cleaning, hauling, winterization, and de-winterization are not included.
- 4) Owner must maintain proper insurance during storage.
- 5) Any work needed on an emergency basis i.e: hauling, removal, repair, etc. Captain John's will do so and charge accordingly. Captain John's reserves the right to move and reassign docks if deemed necessary. Captain John's marina also reserves the right to cancel this agreement and refund pro-rated amounts. Any emergency or concern regarding your boat or dock will be brought to your attention as soon as possible.
- 6) Captain John's is not liable to any damage during storage including but not limited to adverse weather conditions or high winds.
